## God in the under-expected



"Consider the lilies, how they grow: they neither toil nor spin, yet I tell you, even Solomon in all his glory was not clothed like one of these." (Luke 12:27, NRSVue)

One of the deepest and most powerful question in Spiritual Direction is often a variation of four words so many of us have asked at one point or another – Where's God in that?

More often than not, the variations of these four words come among

times of personal crisis or despair, a type of bitter lament, something like, "Well, where's God in that?!" Other times the variations of these words we avoid as if they are words of challenge by some impious person or from an atheist demanding a satisfactory answer to the witnessed suffering in this world – "Tell me, where's your God in that?"

Perhaps avoidance or unwillingness to wrestle with such questions is why it is so difficult to notice the Holy Spirit in our world. It's painfully difficult to listen to the Divine when our daily routines are inundated with fight or flight nervous system responses to the stimuli of 24-hour news cycles, divisive social media,

not to mention the bitterness that consumes those who feel they've been delt some personal slight. As Brené Brown so eloquently says, "when emotions are high, thinking is low."

When listening for the Holy Spirit at work we need our whole selves, our hearts, minds, guts and everything in-between. By making intentional time for reflection rather than stewing or brooding we start to recenter and realign our whole self once again. I can't count the number of times I've heard folks say that something was unexpected, yet when do we pause to acknowledge the under-expected, those things (or people) that we give such little


## WISCONSIN DELLS QUAKE PLANNED FOR FEBRUARY

#### **PASTOR'S REPORT**

- Lois Anderson-Rowzee died August 29, 2025. Service was held Saturday, September 6, 2025
- · August 22 23 St. John's hosted the Northern Illinois Synod event Finding Vitality in Scrappy, Small Congregations. The event was exceptionally well attended, with 64 registered participants. Many thanks to the members of St. John's and our partners at Tri-Church for helping to prepare and organize the hospitality for the event. Thanks also to those who were able to attend and participate in the event. The insights and affirmations gleaned from this time can certainly become inspiration for thinking outside the box and listening for the Holy Spirit at work within and around us.
- Sunday, August 24, was the Sunday School Rally Day. There are currently nine students participating this year.
- September 7, new Confirmation Students received Bibles and Small Catechisms for class. Four students are participating in Confirmation Classes this year; two students will complete their courses in the Spring and affirm their Baptism on June 7. Grateful for the continued collaboration with Immanuel and St. Paul for the shared Tri-Church Confirmation Classes. This sharing continues to provide experiences for students to get to know each other better and delve deeper into conversations about faith life with others in their age group.
- Staff reviews are nearing completion. The last review has been scheduled and will be completed before October.

#### **Approval of Minutes**

 Larry Kradle moved to approve the August 19, 2025, minutes of the Congregation Council as corrected. The meeting date was incorrect. Marci Fisher seconded the motion. Motion carried

#### **Communications**

 The United Way sent a thank you for our support of the Let's Feed Our Children Program.

#### **Finance Report**

- The committee met on September 8th. They reviewed the August financial statements and approved them as presented.
- Jack Flick moved to approve the August financials as approved by the Finance Committee. Larry Kradle seconded the motion, which carried.
- The Committee completed its work on the 2026 Proposed Budget and submitted it to the Congregation Council for review and approval. It is noted that the new Portico Benefits options for Pastor Jacob have been reviewed, but pricing is not yet available. Pastor Jacob stated

- that the Select Option is the closest option to his current benefit option.
- Jack Flick provided the Financial Update as it will appear in the October Messenger and the bulletin insert.

#### **MINISTRY TEAM REPORTS**

#### **Social Ministry**

- The committee met on Saturday, September 13th, to decorate the "Christmas in September" tree in the East Room. This collection will continue through October 26th.
- The "packing party" for the school kits will be held in the fellowship hall on October 1st.
- The Birthday Buddies bowling party took place on Friday, September 12th. A pizza party followed the bowling.
- Discussion continues on funding the distribution of personal care kits from our facility.

#### Stewardship

 The committee is working on a stewardship letter and expects to mail the letter in the first week of November. Discussion centered on the possibilities of including a "time and talents" portion in the letter and/or commitment card.

#### Partners in Prayer and Care:

• The committee met on August 28th. During the month, members made eight nursing home visits and contacted eight shut-ins. Thirty more notes will be sent to inactive members, welcoming them back to worship. To date, no responses have been received from the first mailing. The committee will meet again on September 25th.

#### **Property Line Survey**

 The property lines on the east side of Third Avenue have been surveyed to determine if the tree is on the

Dave Geil, of the Property Committee, feels it is in our best interests to have the survey recorded with the deed to our property in Morrison. The cost for the recording will be an additional \$99.

 Denise Norman moved to approve the additional expenditure of \$99 to record the survey with the deed to our property at the courthouse in Morrison. Paul Wolfe seconded the motion, which carried.

- Two three-year terms and one two-year term will need to be filled for the 2026 Congregation Council. Several names were mentioned as possible names for the ballot.
- Two voting members to the 2026
   Synod Assembly will need to be
   filled. We are also entitled to send
   one youth to the Assembly. Shawn
   Wolfe has agreed to have his name
   considered as a voting member of
   the 2026 Synod Assembly. Denise
   Norman is willing to serve if no other
   female is willing to serve.

#### **NEW BUSINESS**

#### **Approval of July Transfers**

- In August, transfers totaling \$10,500.00 were made from the Undesignated Account #8005 to SVB checking.
- Larry Kradle moved to approve the transfers totaling \$10,500.00. Jack Flick seconded the motion. Motion carried

#### **Visitation Pastor Position**

 During the July 15, 2025, executive session of the Congregation Council, the discussion centered around the elimination of the congregation's Visitation Pastor position. The Personnel Committee

- made this recommendation. This recommendation was based solely on the congregation's financial picture. The discussion celebrated the years of faithful service of Pastor Leo Patterson. A celebration will be held at a later date, with the hope that his family can join us for the event. The annual performance review of Pastor Patterson has been completed, and he is aware of the decision.
- Larry Kradle moved to document the decision to eliminate the Visitation Pastor position. Rhonda Stutzke seconded the motion, which passed.

#### 2026 Budget

- The Finance Committee has completed and presented the proposed 2026. It was noted that the majority of the decrease in the deficit from the previous year is a result of the elimination of the Visitation Pastor position and the part-time status of the Office Manager. It was also noted that the recommendation from the Personnel Committee had been for a 2.5% across-the-board salary increase for all staff. The proposed budget includes a 1.5% salary increase for staff.
- Jack Flick moved to approve the budget as presented. Paul Wolfe seconded the motion, which carried.
- Copies of the proposed budget will be made available to the congregation on Sunday, September 21st.

#### Temple Talk October 5th:

 Jack Flick will present a temple talk during worship on Sunday, October 5th.. The topic will center around the presentation of the proposed budget.

#### **Basement AC Unit:**

 The air conditioning unit in the fellowship hall is not working correctly. The unit is approximately thirty years old. Central Heating and Cooling installed a condenser motor, but the issue remained. The estimated cost for replacing the unit is \$4,500.  Jack Flick moved to have the unit replaced by Central Heating & Cooling, with the funds being taken from the ELCA Parish Nurse investment account. Larry Kradle seconded the motion. Motion carried.

#### Women of the ELCA

· Karen Wolfe asked to address the Council concerning a project she has been involved in with ladies from our Tri-Church family. A group of five ladies recently attended a presentation at LOMC about WELCA and how to organize a chapter. WELCA has a long tradition here at St John's. Recently, in conjunction with Immanuel and St. Paul's, there is a Tri-Church effort to re-establish WELCA as a thriving part of both our church and the Tri-Church. We hope that by acting as a larger group, we will be able to function more strongly and dynamically than as stand-alone churches. We intend that this group will be self-sustaining and not rely on church funding. An informational meeting has been planned for Tuesday, October 14, at 5:30 pm at the Sterling Public Library.

#### **Special Offerings:**

- An updated listing of Special Offering recipients (2009-2025) was provided. Jack Flick moved to designate the October 2025 Special Offerings to First United Methodist Loaves and Fishes, the November Special Offerings to LSSI Holiday Hope Chest, and the December Special Offerings to Sterling Buddy Bags, Wesley United Methodist. Marci Fisher seconded the motion. Motion carried.

## **TNURSE NOTES**Cold Sore Care

A cold sore is a fluid-filled blister — or a group of blisters — that typically develops around the lips. It's caused by the herpes simplex virus, which is typically passed from skin-to-skin contact. To manage cold sores:

Stop the spread — Avoid touching the sore, as that can make it worse and lead to spread. Refrain from kissing or other direct contact. Wash your hands regularly. Don't share food, beverages, towels, lip balms or razors with others. Throw away toothbrushes you used while you had the cold sore.

Treat it early — The nonprescription antiviral cream docosanol (Abreva) may reduce symptoms and shorten recovery time. Docosanol is most effective if used when you first notice tingling or other early signs that indicate a cold sore is forming.

Control the pain — A pain reliever such as acetaminophen (Tylenol, others) or ibuprofen (Advil, Motrin IB, others) may help. Nonprescription cold sore gels or ointments containing

benzocaine, lidocaine or benzyl alcohol also can relieve symptoms. Applying a cool compress or sucking on ice chips may help minimize burning or itching. Dabbing petroleum jelly on the sore and surrounding skin helps reduce dryness and cracking.

Get a prescription — See your primary care physician or a dermatologist if a cold sore lasts for two weeks or keeps recurring. You may be eligible for treatment with an antiviral cream or pill. Antiviral drugs may take hours or even days off your recovery time.

Know the causes — Triggers that may "wake up" the herpes virus to cause cold sores include stress, becoming ill with a cold or the flu, exposure to sunlight or strong winds, changes in the immune system, or hormonal changes.

## **UMC Loaves & Fishes Program**

The special offerings for October have once again been designated by the Congregation Council to be donated to the First United Methodist Church Loaves and Fishes program. This program, located at 501 Broadway, relies solely on contributions to host a free community breakfast and serve more than 400 breakfasts per week. Volunteers have shared that for many people, this might be the only meal they get during the day. Many of the guests are homeless in our community, and so naturally have food insecurities. This program depends on donations to continue, so please consider a generous donation to support this ministry and the growing need for families in our community.

## Tri Church Corner: Cledy's House of Hope



This past spring and summer, Cledy's House of Hope in Rock Falls, a sober living

facility for women, was a God's Work Our Hands project for Tri Church. Some members painted at the facility, while others donated items. In June, Ashley, a staff member from Cledy's, shared her story in a Sunday morning temple talk. Tri Church has committed to continuing its partnership

with Cledy's.

There is so much to learn about Cledy's. The plan moving forward is to have bimonthly information about Cledy's in a question & answer format.

#### Who can live at Cledy's?

 Women 18 years of age and older who are serious about finding long-term recovery from substance abuse (for example – alcohol, drugs, prescription medication).

#### How long can a woman live at Cledy's?

 The program is structured to last around a year but may take an individual less or more time depending on their personal situation. Together with their recovery coach, a personalized recovery plan is developed.

## How does a woman get into Cledy's House of Hope to benefit from its program?

 Staff recommend that a woman transition from the completion of an inpatient program or graduate/ transition from another sober living facility. A woman currently involved in an intensive outpatient program or other recovery program may also be eligible. A letter of recommendation is required from their counselor or caseworker followed by a completed application and a \$50 application fee that covers their background check and drug test upon entrance to Cledy's.
